Railroad terrorism control.

A BILL

for

1 AN ACT relating to railroads; authorizing the appointment
2 of railroad peace officers and specifying their
3 qualifications and authority; specifying responsibility for
4 liability arising from the acts or omissions of railroad
5 peace officers; limiting definitions; and providing for an
6 effective date.

7

8 *Be It Enacted by the Legislature of the State of Wyoming:*

9

10 **Section 1.** W.S. 37-12-131 is created to read:

11

12 **37-12-131. Railroad peace officers.**

13

14 (a) A railroad company may appoint one (1) or more
15 persons to be designated by the railroad company as a
16 railroad peace officer for the protection of railroad
17 property and the protection of the persons and property of

1 railroad passengers and employees. While engaged in the
2 conduct of employment, each appointed railroad peace
3 officer may possess and exercise the powers of a peace
4 officer.

5

6 (b) The peace officer authority may be exercised only
7 in the protection of passengers and employees on or about
8 railroad premises and in the protection of property
9 belonging to passengers, or belonging to or under the
10 control of the railroad employing the railroad peace
11 officers, and in preventing, and making arrest for
12 violation of law upon the premises or in connection with
13 the property.

14

15 (c) A person appointed by a railroad company to act
16 as a railroad peace officer shall, prior to appointment,
17 meet the minimum qualifications established for peace
18 officers pursuant to W.S. 9-1-701 through 9-1-707.

19

20 (d) Before the appointee performs any duties as a
21 railroad peace officer, the railroad company shall file the
22 name of the appointee with the peace officer standards and
23 training commission. If the appointee meets minimum
24 qualifications for a peace officer, the director of the

1 commission shall issue to the appointee a certificate of
2 authority to act as a peace officer, to continue in effect
3 during his employment by the railroad unless revoked by the
4 peace officer standards and training commission for cause.

5
6 (e) A railroad company appointing a railroad peace
7 officer is responsible for any liability arising from the
8 acts or omissions of the railroad peace officer within the
9 scope of railroad employment, but is entitled to any
10 defense to liability that may be available to other peace
11 officers. Neither the state nor any of its political
12 subdivisions is liable for any act or omission of a
13 railroad peace officer.

15 **Section 2.** W.S. 1-39-103(a)(iii), 1-41-102(a)(iv),

17 subparagraph (M), 7-20-101, 9-2-1017(c) and 31-6-101(a)(iv)

2 state who has been appointed as a special deputy sheriff of
3 a Wyoming county pursuant to W.S. 18-3-602(c) ~~;~~ and

5 (M) Any railroad peace officer appointed
6 pursuant to W.S. 37-12-131 who has qualified pursuant to
7 W.S. 9-1-701 through 9-1-707.

9 **7-20-101. Definition of "peace officer".**

12 specified in W.S. 7-2-101, but does not include those
13 officers defined by W.S. 7-2-101(a)(iv)(M).
