AN ACT relating to judicial salaries; increasing judicial salaries and salaries for district attorneys as specified; providing for appropriations; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

Section 1. W.S. 5-1-110 and 9-1-802(d) are amended to read:

5-1-110. Salaries of judges.

(a) Subject to constitutional and statutory provisions concerning when salaries can become effective, judges of the supreme court, district courts and circuit courts shall receive the following annual salaries which shall be paid in equal monthly installments on the last working day of the month:

(i) Supreme court justices shall receive an annual salary of ~~ninety-three thousand dollars (\$93,000.00)~~ one hundred five thousand dollars (\$105,000.00);

(ii) District court judges shall receive an annual salary ~~in an amount equal to ninety percent (90%) of the annual salary provided for supreme court justices of~~ one hundred thousand dollars (\$100,000.00);

(iii) Circuit court judges shall receive an annual salary ~~in an amount equal to seventy-five percent (75%) of the annual salary provided for supreme court justices of~~ eighty-two thousand dollars (\$82,000.00).

(d) Each district attorney shall receive an annual salary ~~in an amount equal to seventy-five percent (75%) of the annual salary provided for supreme court justices of~~ ninety-four thousand five hundred dollars (\$94,500.00).

Section 2.

(a) There is appropriated from the general fund to the supreme court one million three hundred ninety-one thousand eight hundred seventy-eight dollars (\$1,391,878.00) for the period beginning January 6, 2003 through June 30, 2004 to implement the salary formula for judges established under this act.

(b) There is appropriated from the general fund for the period beginning January 6, 2003 through June 30, 2004, to the Natrona county district attorney's office and to the Laramie county district attorney's office forty-four thousand eight hundred forty-four dollars (\$44,844.00) each, to implement salary increases for district attorneys resulting from the salary formula established under this act.
