- 11 **Section 1.** W.S. 42-4-102(a) by creating new
- 12 paragraphs (viii) and (ix), 42-4-103(a) by creating a new
- 13 paragraph (xxviii) and by creating a new subsection (b) and
- 14 42-4-104 by creating new subsections (c) and (d) are

22	calculating all skilled nursing homes' medical assistance
23	per diem base rate reimbursable under this chapter, using

4	(d) The department shall establish by rule the
5	conditions and requirements for skilled nursing home
6	extraordinary care. The requirements shall include, but are
7	not limited to the following:

9	(i) The care shall be previously authorized by
10	the department for each individual and subject to continual
11	audit by the department;

13	(ii) The cost for the care shall clearly exceed
14	the standard skilled nursing home per diem rate;
15	
16	(iii) The cost shall be excluded from the
17	nursing home's cost report to the department; and

19	(iv) No extraordinary care payment shall be made
20	for equipment owned by the nursing home in providing the
21	care.
