1	AN ACT relating to cities and towns; amending provisions
2	regulating mayoral pay; amending provisions regulating pay
3	of councilmen; and providing for an effective date.

5	Be It Enacted by the Legislature of the State of Wyoming:
6	
7	Section 1. W.S. 15-2-103, 15-4-105(a)(i) and (c)(i)
8	and 15-4-201(b) are amended to read:
9	
10	15-2-103. Officers; salaries.
11	
12	The governing body shall fix the salaries for the mayor and
13	councilmen in towns not operating under the commission or
14	city manager form of government. The salaries shall be
15	fixed before their terms begin and shall not change during
16	the term for which they are elected. The salary for mayor

1 shall be paid in twelve (12) or more installments and may 2 not exceed the maximum of four thousand eight hundred 3 dollars (\$4,800.00) twenty-four thousand dollars 4 (\$24,000.00) per year. The salary for each councilman shall 5 be not less than ten dollars (\$10.00) nor more than fifty dollars (\$50.00) one hundred fifty dollars (\$150.00) for 6 actual attendance at each regular or special meeting. All 7 appointed officers shall receive the salary or compensation 8 9 as provided by law or ordinance.

15-4-105. Officers and employees; offices; office 11 12 hours; salaries.

(a) The mayor, commissioners and other officers as 14 provided by ordinance shall have offices in the city hall 15 and shall maintain regular office hours to be fixed by 16 17 ordinance. The compensation of the city officers shall be paid in monthly installments not to exceed the following 18 19 maximum amounts per year:

2	of fifteen million dollars (\$15,000,000.00) or less, the
3	annual salaries shall not exceed the following:

5	(i) Mayor, five thousand one hundred dollars
6	(\$5,100.00) fifteen thousand three hundred dollars
7	(\$15,300.00);
8	
9	15-4-201. Council officers; election; duties;
10	compensation.
11	
12	(b) The salary for each councilman, including <mark>other</mark>
13	than the mayor, shall be not less than ten dollars (\$10.00)
14	nor more than fifty dollars (\$50.00) <u>one hundred fifty</u>
15	dollars (\$150.00), as the council establishes by ordinance,
16	for actual attendance at each regular or special meeting.
17	The salary for the mayor shall not be more than twice the
18	salary of the other council members.
