- 1 The governor may remove any member as provided in W.S.
- 2 9-1-202. The council shall be composed of one (1) woman
- 3 from each of the judicial districts in the state, four (4)
- 4 persons chosen at large and the director of the department
- 5 of employment chief executive officer of the Wyoming
- business council or his designee who shall be an ex officio 6
- member. Not more than nine (9) members shall be from the 7
- same political party. Of the initial members appointed from 8
- 9 each of the judicial districts, three (3) members shall be
- 10 appointed for terms of two (2) years, three (3) members
- 11 shall be appointed for terms of four (4) years and three
