6	Be It Enacted by the Legislature of the State of Wyoming:

8	Section 1. W.S. 31-1-101(a)(xv)(intro), (E)(intro)
9	and by creating a new paragraph (xxix), 31-5-102(a)(xxiii),
10	(xxiv) and by creating a new paragraph (lxii) and
11	31-5-109(a)(xvii) are amended to read:

13	31-1-101. Definitions.
14	
15	(a) Except as otherwise provided, as used in this

2 (xv) "Motor vehicle" means every vehicle which 3 is self-propelled except vehicles moved solely by human 4 power <u>or motorized skateboards</u>. The term includes the 5 following vehicles as hereafter defined:

7 "Motorcycle" means every motor vehicle (E) having a seat or saddle for the use of the rider and 8 9 designed to travel on not more than three (3) wheels in 10 contact with the ground but which may have attached thereto 11 a sidecar for the purpose of transporting a single 12 passenger. For the purpose of registration and titling 13 "motorcycle" includes motorized bicycles and scooters, but 14 excludes mopeds, motorized skateboards and off-road recreational vehicles as defined in subparagraph (K) of 15 16 this paragraph. A recreational vehicle primarily designed 17 for off-road use which is fifty (50) inches or less in width, has an unladen weight of nine hundred (900) pounds 18 or less, has four (4) low pressure tires as defined by 19 20 subparagraph (K) of this paragraph, is designed to be 21 ridden astride a seat or saddle, and is not a golf cart may 22 be registered and titled under this act and is deemed to 23 be:

16	cubic centimeters displacement or with five (5) brake
17	horsepower or less <u>but does not include motorized</u>

20	(xxiv) "Motor vehicle" means every vehicle which
21	is self-propelled except vehicles moved solely by human
22	power, motorized skateboards and golf carts as defined by
23	paragraph (a)(lxi) of this section;

10	(a) This act does not prevent local authorities with
11	respect to streets and highways under their jurisdiction
12	and within the reasonable exercise of the police power
13	from:

15	(xvii) Regulating persons upon skates, coasters,
16	sleds, motorized skateboards and other toy vehicles;

18	Section 2. This act is effective immediately upon
19	completion of all acts necessary for a bill to become law
20	as provided by Article 4, Section 8 of the Wyoming
21	Constitution.
