FIFTY-SIXTH LEGISLATURE OF THE STATE OF WYOMING  
2002 SPECIAL SESSION

AN ACT relating to cities and towns; amending provisions regulating mayoral pay; amending provisions regulating pay of councilmen; and providing for an effective date.

*Be It Enacted by the Legislature of the State of Wyoming:*

**Section 1.** W.S. 15-2-103, 15-4-105(a)(i) and (c)(i) and 15-4-201(b) are amended to read:

**15-2-103. Officers; salaries.**

The governing body shall fix the salaries for the mayor and councilmen in towns not operating under the commission or city manager form of government. The salaries shall be fixed before their terms begin and shall not change during the term for which they are elected. The salary for mayor shall be paid in twelve (12) or more installments and may not exceed the maximum of ~~four thousand eight hundred dollars (\$4,800.00)~~ twenty-four thousand dollars (\$24,000.00) per year. The salary for each councilman shall be not less than ten dollars (\$10.00) nor more than ~~fifty dollars (\$50.00)~~ one hundred fifty dollars (\$150.00) for actual attendance at each regular or special meeting. All appointed officers shall receive the salary or compensation as provided by law or ordinance.

**15-4-105. Officers and employees; offices; office hours; salaries.**

(a) The mayor, commissioners and other officers as provided by ordinance shall have offices in the city hall and shall maintain regular office hours to be fixed by ordinance. The compensation of the city officers shall be paid in monthly installments not to exceed the following maximum amounts per year:

(i) Mayor, ~~twenty-four thousand dollars~~  
~~(\$24,000.00)~~ seventy-two thousand dollars (\$72,000.00);

(c) In cities and towns having an assessed valuation of fifteen million dollars (\$15,000,000.00) or less, the annual salaries shall not exceed the following:

(i) Mayor, ~~five thousand one hundred dollars~~  
~~(\$5,100.00)~~ fifteen thousand three hundred dollars  
(\$15,300.00);

**15-4-201. Council officers; election; duties; compensation.**

(b) The salary for each councilman, ~~including other~~  
~~than~~ the mayor, shall be not less than ten dollars (\$10.00) nor more than ~~fifty dollars (\$50.00)~~ one hundred fifty dollars (\$150.00), as the council establishes by ordinance, for actual attendance at each regular or special meeting. The salary for the mayor shall not be more than twice the salary of the other council members.
