A BILL

for

1 AN ACT relating to state officials' salaries; increasing  
2 the salaries for state elected officials; providing for  
3 current salaries; providing appropriations; and providing  
4 for an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 9-3-101(a)(i) through (v) is amended  
9 to read:

10

11 **9-3-101. Salaries; amount; date of payment.**

12

13 (a) Salaries for clerk of the supreme court and  
14 district court reporters shall be determined by the supreme  
15 court as authorized by legislative appropriations. Subject  
16 to constitutional limitations the following state officers

1 and members of the judiciary shall receive the salaries  
2 indicated by the figures following their respective titles:

4 (i) Governor.....~~\$95,000.00~~ \$150,000.00

6 (ii) Secretary of state....~~\$77,000.00~~ \$120,000.00

8 (iii) State auditor.....~~\$77,000.00~~ \$105,000.00

10 (iv) State treasurer.....~~\$77,000.00~~ \$105,000.00

12 (v) Superintendent of public instruction.....

13 .....~~\$77,000.00~~ \$105,000.00

17 (a) Until such time as the salaries provided by  
18 section 1 of this act become effective, the following  
19 salary schedule shall apply:

21 (i) Governor \$95,000.00;

23 (ii) Secretary of state \$77,000.00;

1 (iii) State auditor \$77,000.00;

3 (iv) State treasurer \$77,000.00;

5 (v) Superintendent of public instruction  
6 \$77,000.00.

8 **Section 3.**

10 (a) For the period beginning January 7, 2003 through  
11 June 30, 2004, there is appropriated from the general fund  
12 to the governor's office ninety-two thousand nine hundred  
13 seventy-eight dollars (\$92,978.00) to implement the  
14 purposes of W.S. 9-3-101(a)(i), as amended by this act.

15

16 (b) For the period beginning January 7, 2003 through  
17 June 30, 2004, there is appropriated from the general fund  
18 to the secretary of state's office seventy-three thousand  
19 four hundred twenty-six dollars (\$73,426.00) to implement  
20 the purposes of W.S. 9-3-101(a)(ii), as amended by this  
21 act.

23 (c) For the period beginning January 7, 2003 through  
24 June 30, 2004, there is appropriated from the general fund

1 forty-eight thousand sixty-nine dollars (\$48,069.00) to  
 2 implement the purposes of W.S. 9-3-101(a)(iii) through (v),  
 3 as amended by this act, to each of the following:

5 (i) The state auditor's office;

7 (ii) The state treasurer's office;

9 (iii) The superintendent of public instruction's  
 10 office.

12 **Section 4.** This act is effective July 1, 2002.
