(b) There is appropriated from the general fund for 1 2 the period beginning January 7, 2003 through June 30, 2004, 3 to the Natrona county district attorney's office and to the 4 Laramie county district attorney's office thirty-eight 5 thousand eight hundred sixty-four dollars (\$38,864.00) 6 each, to implement salary increases for district attorneys 7 resulting from the salary formula established under this 8 act. 9 10 Section 4. This act is effective July 1, 2002.
