1 AN ACT relating to game and fish; requiring governor 2 complimentary big game hunting licenses to be issued to 3 nonprofit organizations; requiring a portion of proceeds 4 from governor and commission complimentary licenses to be remitted to the game and fish fund; specifying use of the 5 proceeds; providing for compliance; and providing for 6 7 effective dates. 8 Be It Enacted by the Legislature of the State of Wyoming: 9 10 Section 1. W.S. 23-1-705(a) and (g) is amended to 11 12 read: 13 23-1-705. Complimentary licenses; one-shot antelope 14 hunt licenses; gunpowder and buckskin hunt licenses; 15 gratuitous licenses. 16

2 (a) At the request of the governor, the commission 3 shall annually issue up to twenty (20) complimentary 4 hunting and twenty (20) complimentary fishing licenses. 5 Not more than five (5) big horn sheep and five (5) moose licenses shall be issued under this subsection. The five 6 (5) year restriction imposed on the receipt of a moose or 7 big horn sheep license by W.S. 23-1-703(b) shall not be 8 9 applicable in any manner to a license issued pursuant to this subsection. Except as provided under subsection (q) 10 11 of this section, no complimentary licenses may be issued at 12 the request of the appointed commissioners. Immediately 13 upon issuance of any of these licenses, the commission 14 shall submit to the secretary of state for maintenance as a 15 public record, the name and address of each licensee and the type of license issued. Any big game license issued 16 17 under this subsection shall be designated to nonprofit 18 charitable organizations. As a condition of accepting the 19 big game license, the organization shall agree to auction 20 or otherwise bid the license to the highest bidder or to 21 raffle the license to members of the public and to remit to 22 the game and fish department not less than fifty percent 23 (50%) of the gross proceeds received for deposit in the 24 game and fish fund for habitat improvement. The department 1 <u>may maintain a civil action against an organization failing</u>
2 <u>to remit proceeds as required and any such organization</u>
3 <u>shall be ineligible for any future license issued under</u>
4 <u>this subsection.</u>

6 addition to complimentary licenses (q) In under 7 subsection (a) of this section, each appointed commissioner may cause to be issued at cost not more than a total of 8 9 eight (8) elk, deer or antelope designated licenses per vear. All licenses issued under this subsection shall be 10 11 designated to nonprofit charitable organizations. As a 12 condition of accepting the license, the organization shall 13 agree to auction or otherwise bid the license to the 14 highest bidder or to raffle the license to members of the 15 public and to remit to the game and fish department not 16 less than fifty percent (50%) of the gross proceeds 17 received for deposit in the game and fish fund for habitat improvement. The department may maintain a civil action 18 19 against an organization failing to remit proceeds as 20 required and any such organization shall be ineligible for 21 any future license issued under this subsection. 22
