1 AN ACT relating to the Wyoming deferred compensation 2 program; providing for state contributions on behalf of 3 participating employees; authorizing contributions under 4 qualified annuity plans at post-secondary education 5 institutions in leiu of deferred compensation; and 6 providing for an effective date.

8 Be It Enacted by the Legislature of the State of Wyoming:

10 Section 1. W.S. 9-3-508 is created to read:

9-3-508. Amount of state's contribution; qualified annuity plan contributions authorized; estimates submitted to state budget officer.

1 (a) The state shall contribute monthly to the program 2 the amount established and appropriated by the legislature 3 for each employee and official contributing to and 4 participating in the program in accordance with subsections 5 (b) and (c) of this section.

6

7 (b) Any state agency, department or institution including the University of Wyoming and the community 8 9 colleges in the state, shall pay monthly to the board the 10 amount established and appropriated by the legislature for 11 each qualified employee or official participating in the 12 program. For purposes of this subsection, "qualified 13 employee or official" means any employee or official 14 contributing monthly to the program through salarv deferrals in an amount equal to or greater than the amount 15 16 specified. To qualify for the state contribution available 17 pursuant to subsection (a) of this section, the employee or official shall contribute monthly to the program from their 18 19 salary an amount not less than the per person amount 20 established and appropriated by the legislature under 21 subsection (a) of this section.

23 (c) Each state agency, department and institution24 shall estimate the amount required for its participation in

the program for the next biennium and shall submit the 1 2 estimate to the state budget officer to be included within 3 the budget request. 4 5 (d) For any qualified employee electing contributions under this subsection instead of under subsections (a) and 6 7 (b) of this section, the University of Wyoming and the community colleges shall contribute monthly to a qualified 8 9 annuity plan under 26 U.S.C. 403(b) for the qualified 10 employee subject to the following: 11 12 (i) The amount computed shall be equal to the 13 amount established and appropriated by the legislature under subsections (a) and (b) of this section; 14 15 (ii) "Qualified employee" as used in this 16

17 subsection means any employee contributing to a qualified 18 annuity plan under 26 U.S.C. 403(b) in an amount equal to 19 or greater than the amount specified under paragraph (d)(i) 20 of this section;

(iii) The university and the Wyoming community college commission shall estimate the amount required for respective participation under this subsection for the next
