Hunting and fishing license selling agents.

Sponsored by: Joint Travel, Recreation, Wildlife and  
Cultural Resources Interim Committee

A BILL

for

1 AN ACT relating to game and fish; modifying provisions  
2 relating to fees charged by hunting and fishing license  
3 selling agents and game tag selling agents for the sale or  
4 distribution of licenses, permits, stamps and tags; making  
5 the fee an additional charge to the price of the license,  
6 permit, stamp or tag; conforming provisions; and providing  
7 for an effective date.

9 *Be It Enacted by the Legislature of the State of Wyoming:*

11 **Section 1.** W.S. 23-1-701(b) and (c) is amended to  
12 read:

13

14 **23-1-701. Selling agents; administration of oaths;**  
15 **game tags.**

1           (b) Each license selling agent shall ~~retain fifty~~  
2 ~~cents (\$.50) for each license and twenty five cents (\$.25)~~  
3 ~~for each conservation stamp under W.S. 23-2-306 he sells.~~  
4 ~~For failure to comply with this section,~~ charge an  
5 additional fee for each license, permit, stamp or tag he  
6 sells or distributes pursuant to this act. Selling agents  
7 shall ~~not be entitled to fifty cents (\$.50)~~ charge a fee of  
8 one dollar and twenty-five cents (\$1.25) per license or tag  
9 and ~~twenty-five cents (\$.25)~~ seventy-five cents (\$.75) for  
10 each conservation permit or stamp sold. ~~and shall be liable~~  
11 ~~on their bond.~~ The fee shall be in addition to the price  
12 established for the license, permit, stamp or tag by this  
13 act. In addition, those game tag selling agents as defined  
14 by commission rule and regulation shall charge a fee of one  
15 dollar and twenty-five cents (\$1.25) per tag. No employee  
16 of the commission shall receive any commission ~~on~~ nor  
17 charge any additional fee for licenses, permits, stamps or  
18 tags sold or distributed pursuant to this act.

20           (c) On or before the 10th of each month every selling  
21 agent shall file a report for the preceding month with the  
22 commission on forms approved by the commission. Selling  
23 agents shall also remit all money collected during the  
24 previous month, less commission ~~excluding the additional~~

1 fees charged pursuant to subsection (b) of this section,  
2 and shall account for and deliver all surplus, unused and  
3 damaged licenses, permits, stamps, tags, and stubs of  
4 licenses received by the selling agent to the commission.

5

6 **Section 2.** This act is effective January 1, 2004.
