- 1 AN ACT relating to motor vehicle license plates;
- 2 authorizing special license plates to be issued to
- 3 firefighters; specifying requirements; providing for
- 4 termination of the issuance and report of the termination

7 Be It Enacted by the Legislature of the State of Wyoming:

9 **Section 1.** W.S. 31-2-218 is created to read:

11 31-2-218. Firefighter's license plates.

- 13 (a) A firefighter employed by a city, county, state
- 14 or duly created fire protection district or a volunteer
- 15 firefighter as defined by W.S. 35-9-601 may apply for
- 16 distinctive license plates for any motor vehicle owned by

1 him upon registration of the vehicle. If the firefighter

2 became a member of a bona fide fire department after

3 January 1, 1995, he shall have a minimum of one (1) year

4 service with the fire department and be firefighter one

5 certified or engine boss wildfire certified in order to

6 apply for the license plate. The fire chief or his

7 designated assistant shall sign a written statement that

8 the applicant is eligible to obtain the license plate.

9 License plates issued under this section shall be displayed

10 upon the vehicle for which they are issued. The license

11 plates shall bear a distinctive symbol and letters

12 identifying the registrant as a firefighter.

13

14 (b) Application for license plates under subsection

15 (a) of this section shall be annually made to the county

16 treasurer as provided by W.S. 31-2-201. The written

17 statement of eligibility required under subsection (a) of

18 this section shall be presented to the county treasurer

19 before a license plate may be issued. Application forms

20 shall be available at all county treasurer's offices. The

21 fee required under W.S. 31-3-102(a)(viii) shall accompany

22 each application.

- 1 (c) No license plate or renewal sticker shall be
- 2 issued under this section without written statement of
- 3 eligibility required under subsection (a) of this section.
- 4 All applications for special license plates provided by
- 5 this section shall be made directly to the county treasurer
- 6 at least thirty (30) days before registration of the
- 7 vehicle expires.

8

- 9 (d) The department of transportation may prepare any
- 10 special forms and issue any rules and regulations necessary
- 11 to carry out this section. A license plate issued under
- 12 this section shall meet the Wyoming department of
- 13 transportation's requirements under W.S. 31-2-217(d)
- 14 relating to the symbol or letters appearing on the license
- 15 plate.

16

- 17 (e) Unless one thousand (1,000) license plates are
- 18 issued under this section before December 31, 2008, the
- 19 plate authorized under this section shall be eliminated
- 20 from production and the department of transportation shall
- 21 report the cessation of production to the legislature not

22 later than January 15, 2009.
