## A BILL

for

- 1 AN ACT relating to elections; granting rulemaking authority
- 2 to the secretary of state to comply with the Help America
- 3 Vote Act of 2002 (HAVA); authorizing the secretary of state
- 4 to develop a state plan under HAVA; authorizing the
- 5 secretary of state to receive and expend federal funds
- 6 authorized under HAVA; providing appropriations; requiring
- 7 a report; and providing for an effective date.

9 Be It Enacted by the Legislature of the State of Wyoming:

- 11 **Section 1.** W.S. 22-2-121 by creating a new subsection
- 12 (d) is amended to read:

13

- 22-2-121. Chief election officer to prepare forms;
- 15 rules; advice.

1 (d) The secretary of state is authorized to adopt
2 rules and regulations necessary to comply with the
3 requirements of the Help America Vote Act of 2002, Public
4 Law 107-252, including a state-based administrative
5 complaint procedure.

## 7 Section 2.

9 (a) Four hundred fifty thousand dollars (\$450,000.00) 10 appropriated from the general fund and 11 appropriated and unexpended under 2001 Wyoming Session 12 Laws, Chapter 137, Section 7, for the design and 13 implementation of a local area network computer operation system, are hereby reappropriated for the purpose of 14 meeting a five percent (5%) state match requirement under 15 16 Help America Vote Act of 2002 the (HAVA). These 17 appropriations, when required by HAVA, shall be placed into an account within the federal revenue fund together with 18 federal requirements payments. Interest earned on the 19 20 account shall be credited to the account. Not to exceed 21 one hundred thousand dollars (\$100,000.00) of these 22 appropriations, prior to segregation into the federal 23 revenue fund, may be expended and accounted for by the

1 secretary of state as may be necessary to develop and

2 submit the required state plan under HAVA.

3

4 (b) As may be authorized by the state plan or as

5 otherwise authorized under HAVA, the secretary of state may

6 accept federal revenues on behalf of the state of Wyoming.

7 Federal payments under sections 101 and 102 of HAVA shall

8 be placed into separate accounts and interest earned shall

9 be credited to the general fund unless prohibited by HAVA.

10 Federal payments under sections 101 and 102 are

11 appropriated and may be expended by the secretary of state

12 as permitted under HAVA.

13

14 (c) On or before January 1, 2004 the secretary of

15 state shall submit a complete report to the legislature of

16 receipts, expenditures, budget information and requests and

17 necessary legislation required under HAVA and this act.

18

19 **Section 3.** This act is effective immediately upon

20 completion of all acts necessary for a bill to become law

21 as provided by Article 4, Section 8 of the Wyoming

22 Constitution.
