Workers' compensation-amendments.

A BILL

for

1 AN ACT relating to worker's compensation; specifying the
2 age at which surviving children's benefits terminate;
3 providing for semimonthly payment of temporary total
4 disability benefits; making a technical correction; and
5 providing for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 27-14-403(b), (c)(intro) and (e)(i)

10 is amended to read:

12 **27-14-403. Awards generally; method of payment.**

13

14 (b) Notwithstanding the date of death or the date of
15 the determination of permanent total disability, in the
16 case of permanent total disability or death, each child of

1 an employee shall be paid one hundred fifty dollars
2 (\$150.00) per month for payments made after July 1, 2001,
3 until the child dies or reaches the age of ~~majority~~
4 eighteen (18) years, whichever first occurs, or if the
5 child is physically or mentally incapacitated until the
6 child dies or attains the age of twenty-one (21) years,
7 whichever first occurs. The amount awarded under this
8 subsection shall be adjusted for inflation annually by the
9 division, using the consumer price index or its successor
10 index of the United States department of labor, bureau of
11 labor statistics.

12

13 (c) All awards stated in ~~subsection (a) of~~ this
14 section except awards under ~~subsections~~ paragraph (a)(i),
15 subsection (b), paragraphs (e)(ii), (iv) and (v) and
16 (h)(ii) and subsection (k) of this section shall be paid
17 monthly at the rates prescribed by this subsection. For
18 permanent partial impairment under paragraph (a)(ii) of
19 this section, the award shall be paid monthly at the rate
20 of two-thirds (2/3) of the statewide average monthly wage
21 for the twelve (12) month period immediately preceding the
22 quarterly period in which the injury occurred as determined
23 pursuant to W.S. 27-14-802. For temporary total disability
24 under paragraph (a)(i) of this section, the award shall be

1 ~~paid monthly~~ calculated at the rate of two-thirds (2/3) of
2 the injured employee's actual monthly earnings at the time
3 of injury but not to exceed the statewide average monthly
4 wage for the twelve (12) month period immediately preceding
5 the quarterly period in which the injury occurred as
6 determined pursuant to W.S. 27-14-802 with one-half (1/2)
7 of the monthly award paid on or about the fifteenth of the
8 month and one-half (1/2) paid on or about the thirtieth of
9 the month. For permanent partial and permanent total
10 disability or death under paragraphs (a)(iii), (iv) and (v)
11 of this section, the award shall be paid monthly computed
12 as follows:

13

14 (e) If an injured employee dies as a result of the
15 work related injury whether or not an award under
16 paragraphs (a)(i) through (iv) of this section has been
17 made:

19 (i) All awards under paragraphs (a)(i) through
20 ~~(iii)~~ (iv) of this section shall cease as of the date of
21 death;

1 **Section 2.** This act is effective July 1, 2004.
