AN ACT relating to state officers; creating a select legislative committee to study administrative issues relating to state elected officers; providing an appropriation; providing for a report; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

Section 1.

- (a) There is created a select legislative committee to study administrative issues relating to the offices of the secretary of state, state auditor, state treasurer and state superintendent of public instruction. The committee shall consist of:
- (i) Three (3) representatives from the house, with not more than two (2) members from the same political party. The members shall be appointed by the speaker of the house, who shall also appoint a cochairman of the committee;
- (ii) Three (3) senators from the senate, with not more than two (2) members from the same political party. The members shall be appointed by the president of the senate, who shall also appoint a cochairman of the committee.
- (b) The committee shall study issues specified in this subsection relating to the offices of the secretary of state, state auditor, state treasurer and state superintendent of public instruction. Those specified officers and any state agency shall provide information and other support to the committee as requested. The legislative service office shall staff the committee. The

committee shall report to the management council its findings, including any recommendations for statutory changes. The report shall be provided not later than September 30, 2004. The committee shall study:

- (i) Constitutional and statutory duties assigned to the specified offices;
- (ii) The roles of the offices in the structure
 of state government;
- (iii) Appropriate legal representation of the offices;
- (iv) Appropriate budgetary oversight of the offices;
- (v) Appropriate oversight of staff serving the offices and boards and commissions upon which the specified officers serve.
- (c) There is appropriated from the general fund to the legislative service office nineteen thousand dollars (\$19,000.00) or as much thereof as is necessary for purposes of this act.
