A BILL

for

1 AN ACT relating to department of correction facilities;  
2 amending names of department of correction facilities;  
3 establishing location of a medium security correctional  
4 institution; repealing obsolete references; and providing  
5 for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

8

9       **Section 1.**     W.S. 25-1-104(b)(ii), (iv) and (v),  
10 (d)(iv)(A), (e)(intro), 25-1-201(a)(xi) and by creating  
11 new paragraphs (xiii) and (xiv) are amended to read:

12

13       **25-1-104. Creation of department of corrections;**  
14 **duties; inspections of state institutions; regulation of**  
15 **prisoner-produced goods.**

2 (b) The department of corrections has general  
3 supervision, control and custody of all penal institutions,  
4 and responsibility for the maintenance and repair of all  
5 buildings and grounds utilized by the institutions.  
6 Specifically the department has general supervision and  
7 control of, and shall provide for the care and maintenance  
8 of all inmates in the following state institutions:

9

10 (ii) Wyoming ~~state penitentiary~~ honor farms and  
11 camps;

12

13 (iv) Wyoming medium correctional ~~facility~~  
14 institution;

15

16 (v) Adult community correctional facilities  
17 defined by W.S. 7-18-102(a)(i).

19 (d) The director shall:

20

21 (iv) Appoint, prescribe the duties of, and  
22 remove at will the following officers:

23

1 (A) Wardens of the Wyoming state  
 2 penitentiary, medium correctional institution, ~~and~~ women's  
 3 center and Wyoming honor farms and camps;  
 4

5 (e) The officers provided for under W.S.  
 6 25-1-104(d) (iv) (A) ~~through (C)~~ and (D) shall:  
 7

8 **25-1-201. Establishment of state institutions.**  
 9

10 (a) The following state institutions are established:  
 11

12 (xi) The Wyoming medium correctional facility at  
 13 ~~Level~~ (Torrington, Riverton and Rawlins are being  
 14 considered for the site of the facility-no choice has been  
 15 made at the time of this bill draft), Wyoming;  
 16

17 (xiii) The Wyoming honor farm at Riverton,  
 18 Wyoming;  
 19

20 (xiv) The Wyoming honor conservation camp at  
 21 Newcastle, Wyoming.  
 22

23 **Section 2.** W.S. 25-1-104(d) (iv) (B) and (C) are  
 24 repealed.
