The driver 16 17 of any bus, limousine or recreational vehicle is prohibited from consuming or having any alcoholic beverage within the 18 19 driver's zone of control. 20 21 (e) This section shall not apply within the 22 boundaries of any incorporated municipality that has 23 adopted an ordinance prohibiting transportation or
