2 (\$150.00) per month for payments made after July 1, 2001, 3 until the child dies or reaches the age of majority 4 eighteen (18) years, whichever first occurs, or if the 5 child is physically or mentally incapacitated until the child dies or attains the age of twenty-one (21) years, 6 7 whichever first occurs. The amount awarded under this subsection shall be adjusted for inflation annually by the 8 9 division, using the consumer price index or its successor 10 index of the United States department of labor, bureau of 11 labor statistics. 12 13 (c) All awards stated in subsection (a) of this 14 section except awards under subsections paragraph (a) (i), 15 subsection (b)  $\tau$  and paragraphs (e) (ii), (iv) and (v) and 16 (h)(ii) of this section shall be paid monthly at the rates 17 prescribed by this subsection. For permanent partial impairment under paragraph (a)(ii) of this section, the 18 19 award shall be paid monthly at the rate of two-thirds (2/3) 20 of the statewide average monthly wage for the twelve (12) 21 month period immediately preceding the quarterly period in 22 which the injury occurred as determined pursuant to W.S.

27-14-802. For temporary total disability under paragraph

(a) (i) of this section, the award shall be paid monthly

1 semimonthly at the rate of two-thirds (2/3) of the injured

2 employee's actual monthly earnings at the time of injury

3 but not to exceed the statewide average monthly wage for

4 the twelve (12) month period immediately preceding the

5 quarterly period in which the injury occurred as determined

6 pursuant to W.S. 27-14-802. For permanent partial and

7 permanent total disability or death under paragraphs

8 (a)(iii), (iv) and (v) of this section, the award shall be

9 paid monthly computed as follows:
