Any person creating a lien under this paragraph shall file the 3 4 lien in the office of the secretary of state. 5 29-7-102. Selling or removing encumbered property 5 without lienholder's consent; penalty. 6 7 Any owner of a female animal or offspring on which a lien exists under W.S. 29-7-201 through 29-7-207 who disposes of 8 9 any female animal or offspring before the lien expires or 10 is satisfied or who removes the female animal or offspring 11 out of the county in which the notice of lien is filed with 12 intent to deprive a lien claimant of his lien or with 13 intent to damage an innocent purchaser, and does so without first having obtained the consent of the lienholder to the 14 disposition is quilty of a misdemeanor. On conviction he 15 may be fined not more than seven hundred fifty dollars 16 17 (\$750.00). 18 19 Section 2. This act is effective July 1, 2004. 20 21 (END)
