36-8-1401. Purchase of lands; description of lands.

15 (a) The board of land commissioners is hereby

16 authorized and empowered to purchase in the name of the

17 state of Wyoming and to pay an amount not to exceed twenty-

- 2 appraisal or one hundred ten percent (110%) of the
- 3 appraised value, whichever is less, for the homestake lands
- 4 in Crook county containing approximately thirty thousand
- 5 six hundred (30,600) acres which are hereby declared to be
- 6 state lands to be known as the homestake lands.

8 36-8-1402. Administration.

- 10 The board of land commissioners shall hold title to and
- 11 administer the homestake lands. The lands shall be
- 12 administered in a manner to obtain a reasonable return on
- 13 the lands for the benefit of public schools.

- 17 (a) Notwithstanding W.S. 9-4-310 (b), twenty-four
- 18 million dollars (\$24,000,000.00), or as much thereof as is
- 19 necessary, is appropriated to the state land board from the
- 20 common school permanent land fund for the purposes of this
- 21 act.

- 23 (b) Notwithstanding subsection (a) of this section,
- 24 two hundred thousand dollars (\$200,000.00), or as much

1 thereof as is necessary, is appropriated from the general 2 fund to the state land board for necessary expenses 3 required to review the proposed purchase of land 4 provided in section 1 of this act and for securing an 5 option to purchase the lands to allow a reasonable time to inventory the land and its assets. Prior to purchasing the 6 7 land described in section 1 of this act, the state land board shall submit additional information regarding the 8 9 lands, develop and submit recommendations to the joint appropriations interim committee as to how the lands should 10 be managed. On or before December 1, 2004, the state land 11 12 shall submit a final recommendation to board the 13 legislature regarding how the lands should be held, managed 14 or disposed of.

Section 3. This act is effective July 1, 2004.
