- 9-1-702. Created; membership; removal; compensation;

4 (iv) Prescribe reasonable minimum qualifications
5 relating solely to physical, mental and moral fitness for
6 persons recruited, appointed or retained as peace officers

7 or dispatchers by the state or a political subdivision;

10 peace officers <u>and dispatchers</u> for substantial failure to
11 comply with this act or the rules of the commission,

as a dispatcher on a permanent or temporary basis unless 1

2 the person has been awarded a certificate by the director

4 attesting to his satisfactory completion of a commission

5 approved dispatcher basic training program. No county,

sheriff, mayor, municipality, state agency or any other 6

person authorized by law to employ dispatchers in this 7

state shall employ any person as a dispatcher who does not 8
