8 Be It Enacted by the Legislature of the State of Wyoming:

- 12 (a) There is appropriated from the budget reserve
- 13 account to a separate account within the treasurer's office
- 14 four million six hundred thousand dollars (\$4,600,000.00)
- 15 to assist county memorial hospitals and hospital districts
- 16 in obtaining prior acts coverage under the local government

1 self-insurance program. This appropriation shall be used,

2 upon application as described in subsection (b) of this

3 section, by the local government self-insurance joint

4 powers board, defined in W.S. 1-42-201, to ensure that

5 county memorial hospitals and hospital districts do not

6 endure a lapse in coverage due to obtaining coverage under

7 the local government self-insurance program. In using this

8 appropriation, the local government self-insurance joint

9 powers board may, at its discretion and on a case by case

10 basis, elect to procure coverage from an outside insurer

11 for prior events not covered due to the expiration of the

12 period for making claims under the county memorial

13 district's or hospital district's prior insurance policy,

14 or may elect to extend coverage under the local government

15 self-insurance program to claims that occurred during the

16 time of the lapse in coverage.

18 (b) Application to obtain coverage under this section

19 shall be submitted to the local government self insurance

20 joint powers board with the following information:

22 (i) A copy of the hospital district or county

23 memorial hospital's current insurance policy including a

24 statement of the current annual premium;

5 (iii) A description of all outstanding claim 6 periods for which coverage is needed.

(c) Upon approval of coverage under the 8 government self-insurance program, the state treasurer 9 10 shall transfer from the separate account to the account 11 designated by the local government self-insurance program 12 joint powers board pursuant to W.S. 1-42-113(a)(i), the 13 amount necessary to procure coverage from an outside 14 insurer for prior events not covered due to the expiration of the period for making claims under the county memorial 15 hospital's or hospital district's prior insurance policy, 16 17 or to extend coverage under the local government selfinsurance program to claims that occurred during the time 18 of the lapse in coverage, as determined by the local 19 20 government self-insurance program joint powers 21 pursuant to subsection (a) of this section. Application 22 for prior acts coverage under this section may only be submitted once, shall be submitted prior to a hospital 23 district or memorial hospital's election to obtain coverage 24
