(c) The department may offer engineering or other 1 2 technical advice to any municipality, county, joint powers 3 board or other qualified party in connection with the 4 construction, maintenance or operation of airports. 5 commission shall encourage: 6 (iii) Study of aeronautical aerospace 7 engineering and allied subjects in the various schools of 8 9 Wyoming and assist in forming classes in aviation; 10 11 (v) Sponsorship and participation in aerospace 12 education workshops. 13 14 10-5-202. Airport board; organization; corporate 15 powers; personal liability; compensation; appointment of 16 manager. 17 (a) The authority and powers granted in W.S. 10-5-101 18 19 through 10-5-204 and the control of funds named may be 20 under the control of an airport board.
