4 **24-16-102**. Definitions.

- 6 As used in this chapter, "utility corridor" means an area
- 7 of highway right-of-way designated or used for the joint
- 8 location of utilities, either public or private.

9

10 24-16-103. Location of pipelines and utilities.

11

- 12 (a) The transportation commission may allow parallel
- 13 pipeline or line encroachments within the highway right-of-
- 14 way.

15

- 16 (b) When parallel encroachment is allowed, the
- 17 facilities shall be located as close to the highway right-
- 18 of-way line and as far from the highway centerline as
- 19 possible.

- 21 (c) Support facilities for pipelines, including
- 22 storage tanks, valves, clean-out traps, compressors,
- 23 cathodic protection fields, rectifiers and similar

1 facilities shall be located off the highway right-of-way

2 whenever possible.

4 (d) Pressure regulators, whether in huts or vaults,

5 metering equipment, hydrants and service line shut-off

6 valves shall be located off the highway right-of-way

7 whenever possible.

9 **Section 2.** W.S. 24-2-102(a)(i)(G), (H), by creating a

10 new subparagraph (J) and (b) is amended to read:

12 24-2-102. General powers; power of eminent domain

13 limited.

15 (a) To construct, maintain and supervise the public

16 highways of this state, the department of transportation is

17 authorized to:

19 (i) Acquire, hold and manage real property in

20 the name of the transportation commission and to develop,

21 improve, operate and maintain the same for any necessary

22 public purpose. Lands acquired for rights-of-way for

23 highways may be up to three hundred (300) feet wide and

24 greater where extra width is necessary for:

4 (H) Scenic roadside areas: and

6 (J) Utility corridors.

8 (b) The commission shall not acquire property by
9 eminent domain except for highway rights-of-way as
10 specified by subparagraphs (a)(i)(A) through (F) and (J) of
11 this section and only if the property for those purposes is

12 immediately adjacent to the highway right-of-way.
