AN ACT relating to libraries; providing for the state law librarian to exchange statutes with libraries of other states; clarifying language relating to inspection of library records; providing requirements for filing certificates of organization; and providing for an effective date.

*Be It Enacted by the Legislature of the State of Wyoming:*

**Section 1.** W.S. 5-2-502 is created to read:

**5-2-502. Session law exchange.**

Upon request, the state law librarian shall send to the library of each state and territory of the United States, free of expense, one (1) copy of the session laws of this state in exchange for the laws of the requesting state or territory. All the laws received in the exchange shall be deposited by the state law librarian in the state law library and become the property of this state.

**Section 2.** W.S. 16-4-203(d)(ix) and 18-7-105(b) are amended to read:

**16-4-203. Right of inspection; grounds for denial; access of news media; order permitting or restricting disclosure; exceptions.**

(d) The custodian shall deny the right of inspection of the following records, unless otherwise provided by law:

(ix) Library ~~circulation~~patron transaction and registration records except as required for administration of the library or except as requested by a custodial

parent or guardian to inspect the records of his minor child;

**18-7-105. Organization of board; rules and regulations; filing of certificate of organization; incorporation; recovery of library materials; establishment of branch libraries; cooperative library service.**

(b) Upon filing of the certificate the board of directors is a body corporate, with power to sue and be sued under the name ~~of "Board of Directors of the County Library of .... County", or the board by resolution filed as provided for filing of certificate of organization, may designate itself as "Board of Directors of Carnegie Public Library of .... County"~~ on file with the secretary of state.

**Section 3.** W.S. 9-2-1026.6(e) is repealed.
