- AN ACT relating to the department of health; authorizing the Wyoming state hospital, with assistance from the office of rural health, to recruit and hire psychiatrists as specified; authorizing educational loan forgiveness; authorizing the office of rural health to administer the

12 **Section 1.** W.S. 9-2-125 is created to read:

1 (a) The Wyoming state hospital is authorized, with

2 assistance from the office of rural health, to hire and

3 enter into agreements with psychiatrists who have graduated

4 from accredited residency programs to provide health care

5 in this state. A psychiatrist hired under this section

6 shall be an employee of the Wyoming state hospital. The

7 agreement between the state hospital and the psychiatrist

8 shall:

10 (i) Provide for the psychiatrist to practice
11 psychiatric medicine in a community of the state as
12 directed by the state hospital. A psychiatrist shall agree
13 to provide psychiatric medical care for the period of the
14 contract in underserved areas of the state to patients in
15 need of acute psychiatric care which the psychiatrist is
16 qualified to provide. The state hospital shall determine

which areas of the state are underserved;

19 (ii) Provide that the psychiatrist shall be
20 repaid up to one hundred thousand dollars (\$100,000.00) of
21 the amount of outstanding educational loans the
22 psychiatrist has acquired after completing undergraduate
23 programs and as a direct result of medical school training

- 2 of this section;

- 4 (iii) Require the psychiatrist to practice for a
- 5 minimum of four (4) years under the agreement;

- 7 (iv) Contain other provisions the state hospital
- 8 deems necessary or appropriate to accomplish the purposes
- 9 of this section.

- 11 (b) The Wyoming state hospital, in consultation with
- 12 the office of rural health, shall promulgate rules
- 13 necessary to carry out the purposes of this section. In
- 14 carrying out this section the state hospital shall assess
- 15 health care needs of the state by geographic areas and
- 16 practice specialties and shall prioritize and enter into
- 17 agreements under this section accordingly.

- (\$3,255,000.00), or as much thereof as necessary, to 10

- 12 psychiatrists under this act, to be expended as follows:

- 14 (i) One hundred five thousand dollars
- 15 (\$105,000.00) for recruitment and relocation expenses;

- dollars (\$2,450,000.00) for salaries; and 18

- 21 (\$700,000.00) for the educational loan forgiveness program

2 full-time equivalent positions to hire psychiatrists to

3 work for the Wyoming state hospital under this act.

5 Section 4. This act is effective July 1, 2006.
