1 (i) "Resident" means a person, partnership, limited partnership, registered limited partnership, 2 3 registered limited liability company or corporation 4 certified as a resident by the department of employment 5 prior to bidding upon the contract, subject to the following criteria: and subject to W.S. 16-6-102(d): 6 7 (A) Any person who has been a resident of 8 9 the state for one (1) year or more immediately prior to bidding upon the contract; or 10 11 12 (B) A partnership, or association, each 13 member of which has been a resident of limited partnership, 14 registered limited partnership, registered limited 15 liability company or corporation which has maintained an office and place of business within the state for one (1) 16 17 year or more immediately prior to bidding upon the 18 contract. + 19 20 (ii) "Principal office" and "principal place of 21 business" shall have the meaning as the department of 22 employment determines, consistent with the purpose of this act, by rule and regulation "Office and place of business" 23
