A BILL

for

- 1 AN ACT relating to government services; authorizing the
- 2 governor to establish partnerships among state and local
- 3 governments and non-government agencies, as specified, to
- 4 study and report on government health, human services and
- 5 education programs; establishing criteria for those
- 6 programs as specified; providing for reports; and providing
- 7 for an effective date.

9 Be It Enacted by the Legislature of the State of Wyoming:

11 Section 1.

- 13 (a) The governor shall establish a partnership to
- 14 include appropriate state and local government and non-

1 government agencies including but not limited to the

2 executive branch, the department of education, local school

3 districts, the judiciary, business, non-profit and faith

4 organizations, professional organizations, the Tribes, the

5 community college commission and the University of Wyoming.

6 The partnership shall study and make recommendations for

7 improving the effectiveness of state and local health,

8 human services, and education programs. The partnerships

9 shall continue the pursuit of the following goals

10 identified by the children and families initiative for the

11 well-being and support of Wyoming children and families:

13 (i) Wyoming families and individuals living in

14 stable, safe, supportive, nurturing, healthy environments;

15

16 (ii) Wyoming's economy providing people with a

17 livable income that ensures wage equality;

18

19 (iii) All people having affordable health care

20 and insurance;

21

22 (iv) All Wyoming students being successfully

23 educated and prepared for life's opportunities;

(v) All children being born healthy, achieving their highest potential during their early development years and entering school ready to learn with the support of families and communities. (b) The success of the partnership's efforts to achieve the results set forth in subsection (a) above shall be measured by the following indicators: (i) Rate of abuse and neglect of children; (ii) Drug and alcohol use by juveniles; (iii) Domestic violence rates; (iv) Rate of divorce; (v) Suicide rates; (vi) Car crash deaths among persons younger than twenty-five (25) years;

(b) The partnership created under this act shall 4 collaborate with community partnerships for 5 children, families and individuals in each of the geographical 6 7 regions of the state. Community partnerships may consist of 8 citizens, consumers of health, human services and education family members, governmental 9 programs, agencies nongovernmental organizations providing health, education 10 and human services, economic development representatives 11 12 and business leaders, members of faith and non-profit organizations and any other individuals and groups who can 13 contribute to the activities of the community partnership. 14 Community partnerships may develop and implement local 15 16 strategies for improving the social well-being of children 17 and families, and shall advise the governor, human services agencies, the judiciary, and the department of education 18 19 concerning effective implementation of state and local 20 health, human services, and education programs.

22 (c) Annually, on or before December 1, the governor 23 shall report to the legislature, concerning:

2 (i) The activities of the state, community and

3 partnerships for children, families and individuals

4 established under this act;

6 (ii) The well-being of children and families as

7 measured by the indicators set forth in subsection (b) of

8 this act to include an analysis of the trends demonstrated

9 by these measurements;

11 (iii) Any other findings or recommendations

12 relating to improving the effectiveness of state and local

13 health, human services, and education programs.

15 Section 2. This act is effective July 1, 2006.
