A BILL

for

1 AN ACT relating to administration of government; modifying
 2 organization, powers and duties of the state employee
 3 compensation commission; providing for commission
 4 recommendations to be included in the state budgeting
 5 process as specified; and providing for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 9-2-1012 by creating a new subsection
 10 (g) and 9-2-1019(e) and by creating a new subsection (h)
 11 are amended to read:

13 **9-2-1012. Duties of budget division; transmittal of**
 14 **standard budget and manual; return of completed exception**
 15 **and expanded budgets; submission to governor; disposition**
 16 **of excess general fund appropriations; submission of**

1 **selected budget information to joint appropriations interim**
2 **committee.**

4 (g) The state employee compensation commission shall
5 submit to the budget division within the time periods
6 specified in subsection (a) of this section its
7 recommendations regarding state employee compensation. The
8 budget division and department shall consider those
9 recommendations in developing budgets and submitting
10 recommendations to the governor pursuant to subsection (b)
11 of this section. When distributing the overall state
12 budget to the legislature, the governor shall forward the
13 recommendations of the state employee compensation
14 commission and shall summarize the manner in which the
15 proposed budget reflects those recommendations.

17 **9-2-1019. Personnel hearings; state employee**
18 **compensation commission created; duties.**

20 (e) The state employee compensation commission is
21 created to review issues related to employee compensation.
22 The commission shall consist of not more than five (5)
23 members to serve two (2) year terms. Three (3) members
24 shall be appointed by the management council of the

1 legislature of whom one (1) shall be from the private
2 sector, and one (1) each from the senate and house of
3 representatives, and two (2) members shall be appointed by
4 the governor, of whom one (1) shall be from the private
5 sector. The commission shall elect a chairman from among
6 its two (2) legislative members.

8 (h) The commission:

9
10 (i) Shall function as a liaison between the
11 legislature and the governor and executive branch agencies
12 on matters concerning state employee personnel issues;

13
14 (ii) May hold public hearings regarding any of
15 its duties;

16
17 (iii) May make and enter into contracts
18 necessary or incidental to carry out any of its duties;

19
20 (iv) May recommend legislation on matters
21 concerning state employee personnel issues. Any
22 recommendations from the commission shall be submitted to
23 the management council of the legislature;

24

1 (v) Shall appear before the joint appropriations
2 committee as requested by the committee to present
3 recommendations submitted by the commission pursuant to
4 W.S. 9-2-1012(g).

5

6 **Section 2.** This act is effective July 1, 2007.
