| 10 | Section 1. W.S. 22-5-216, 22-6-107, 22-6-118(a), |
| 11 | 22-6-119(a)(iii), (iv) and (vi), 22-6-120(a)(xi), (xii) and |
| 12 | (xv), 22-6-121, 22-6-123, 22-6-124, 22-8-106, 22-14-107 and |
| 13 | 22-16-108 are amended to read: |

15 **22-5-216.** Nomination of nonpartisan candidates.

| 2 | Subject to additional requirements of this section, for |
| 3 | each nonpartisan office the candidates equal in number to |
| 4 | twice the number to be elected to the office, who receive |
| 5 | the largest number of votes, shall be nominated and shall |
| 6 | be entitled to have their names printed on the nonpartisan |
| 7 | ballot for the next general election. A write-in candidate |
| 8 | shall not be nominated and shall not be entitled to have |
| 9 | his name printed on the ballot for the next general |
| 10 | election unless he received at least three percent (3%) of |
| 11 | the votes cast for that office. An elector may vote for no |
| 12 | more than the number of candidates to be elected for each |
| 13 | nonpartisan office. |

Format of partisan general election ballot. 13 The general election partisan ballot shall be 14 (a) printed in substantial compliance with this format: 15 16 17 (xi) Adjacent to the right of the name of each candidate, except those running for the office of president 18 and vice-president of the United States and their electors, 19 20 and after adjacent to each blank line for write-in 21 candidates, shall be printed a square for marking the vote.

A single square shall be printed to indicate the vote for

4 (xii) Adjacent to the right of the description 5 of any office to be filled by more than one (1) candidate shall be printed "Vote For Not More Than", then the 6 appropriate words and figures designating the proper number 7 to be elected; 8

10 (xv) Directly Adjacent to the right of the final line of such statement shall be printed two (2) squares on 11 12 the same line. Above the first square shall be printed the 13 word "For" and above the second square shall be printed the 14 word "Against";

16 22-6-121. Political party ballot position on general election ballot; order of candidates' names. 17

19 (a) Political party position shall be determined on 20 the general election ballot according to the number of 21 votes received by each party within the county for the 22 office of representative in congress at the last preceding general election. The party receiving the highest number 23 24 of votes shall appear first following the names of the

offices to be voted for and other parties shall follow in 1 2 the order of their respective numbers of such votes. The 3 order of any provisional parties will be drawn by the 4 secretary of state. Any independent candidates shall 5 appear following the last party and shall listed in alphabetical order, subject to rotation. When more than 6 one (1) candidate is to be elected to a particular office, 7 the names of candidates shall be printed in alphabetical 8 9 order, subject to rotation, on all ballots for electronic 10 and machine voting systems as defined by W.S. 22-1-102.

12 22-6-123. Nonpartisan election ballots and ballot 13 propositions.

14

15 Primary and general election ballots for nonpartisan 16 offices and ballot propositions shall be printed on yellow 17 paper or paper with yellow demarcation as provided by rule and regulation of the secretary of state, separate from 18 19 partisan ballots. They shall contain no political party designations, but otherwise shall conform to the same 20 21 general requirements for official partisan ballots except 22 as otherwise specifically provided.
