10	Section 1. W.S. 23-1-504 is created to read:

Not later than July 30, 2007, and not later than 1 (a) 2 the last day of each month thereafter, the chief fiscal 3 officer of the game and fish department shall prepare and 4 certify a report of licenses sold or distributed in the 5 previous month under the following statutes: 6 7 (i) W.S. 23-2-201(d)(iii) and (iv) and (g); 8 9 (ii) W.S. 23-2-101(j)(xi), (xvi), (xvii), (xx), (xxi), (xxxii) and (xxxiii); 10 11 12 (iii) W.S. 23-2-301(c)(xiii); 13 14 (iv) W.S. 23-1-705(a), (d), (e) and (g). 15 The chief fiscal officer of the game and fish 16 (b) 17 department shall submit to the state auditor the report created under subsection (a) of this section with a voucher 18 for the number of licenses of each type sold or distributed 19 20 multiplied by the difference between the amount received by 21 the department for that license and the cost of a full 22 price adult license corresponding with each type of license sold or distributed. 23

Upon receipt of the report and voucher, the state 1 (C) 2 auditor shall transfer to the game and fish fund the amount 3 claimed on the voucher from funds appropriated for this 4 program to the extent available.

5

6 The game and fish department shall prepare a (d) 7 biennial budget request prior to each budget session of the legislature for the purpose of funding the free and reduced 8 9 price license revenue recoupment program and shall submit 10 the request to the governor pursuant to W.S. 9-2-1010 11 through 9-2-1013.

13 Section 2. There is appropriated to the game and fish million four hundred thousand dollars 14 department one (\$1,400,000.00) from the general fund for the period 15 16 beginning July 1, 2007 and ending June 30, 2008. Funds 17 appropriated under this section shall only be expended for the purpose of funding the free and reduced price license 18 revenue recoupment program and shall not be expended for 19 20 any other purpose.

Section 3. This act is effective July 1, 2007. 22
