## A BILL

for

- 1 AN ACT relating to the military department; authorizing the
- 2 purchase of real property for use by the military
- 3 department; specifying requirements for purchase; requiring
- 4 reports; providing an appropriation; and providing for an
- 5 effective date.

7 Be It Enacted by the Legislature of the State of Wyoming:

8

- 9 **Section 1.** Upon approval by the governor and subject
- 10 to the provisions of this act, the adjutant general may
- 11 purchase in the name of the Military Department of the
- 12 State of Wyoming, real property in the vicinity of Camp
- 13 Guernsey, Wyoming.

2 (a) The military department shall identify land in 3 the area of Camp Guernsey, Wyoming, that if purchased by 4 the Wyoming military department, would increase the 5 capabilities of Camp Guernsey as a military training and 6 operations site or protect Camp Guernsey from private or

public encroachment that may inhibit future military use.

9 (b) The military department shall assess the utility
10 of any real property identified under subsection (a) of
11 this section, and may negotiate accordingly for the
12 purchase of any identified real property.

13

14 (c) Prior to purchasing any real property as
15 authorized by this act, the military department shall
16 obtain an appraisal of the real property from a Wyoming
17 certified general appraiser, and shall consider the
18 appraisal value prior to purchasing any real property under
19 this act.

20

21 (d) The military department shall obtain a mineral 22 title report prior to purchasing any real property under 23 this act, and shall obtain a title insurance commitment 24 prior to concluding closing proceedings of any purchase.

2 (e) The military department shall report any actions taken under this act to the governor and to the joint 3 transportation, highways and military affairs 4 5 committee not later than September 1, 2007. The military department shall report any purchase under this act to the 6 7 joint transportation, highways and military affairs interim committee within thirty (30) days after closing on any real 8 9 property.

10

Section 3. There is appropriated ten million dollars 11 12 (\$10,000,000.00) from the budget reserve account to the 13 military department for the purposes of this act. This funding may be used for the actual purchase of real 14 property, as well as for administrative expenses related to 15 any real property purchase including environmental 16 17 management and infra-structure requirements for initial Funds not expended or obligated in 18 military use. accordance with this act shall lapse as provided by W.S. 19 20 9-4-207(c) on June 30, 2008.

1 Section 4. This act is effective immediately upon

2 completion of all acts necessary for a bill to become law

3 as provided by Article 4, Section 8 of the Wyoming

4 Constitution.
