Before making distributions from the severance 7 tax distribution account under subsections (c) through (e) 8 9 (f) of this section, an amount equal to two-thirds (2/3) of 10 the amount of tax collected under W.S. 39-14-104(a)(i) and 11 (b)(i) and 39-14-204(a)(i) for the same period shall be

deposited into the permanent Wyoming mineral trust fund.

14 (d) After making distributions under subsections (b) and (c) of this section, distributions under subsection (e) 15 16 of this section shall be made from the severance tax 17 distribution account. The amount of distributions under subsection (e) of this section shall not exceed one hundred 18 fifty-five million dollars (\$155,000,000.00) in any fiscal 19 20 year. To the extent that distributions under subsection (e) 21 of this section would exceed that amount one hundred fifty-22 five million dollars (\$155,000,000.00) but be less than or equal to double the amount of revenue specified in 23

2	excess shall be credited <u>distributed</u> :

4	(f) To the extent that the amount of distributions
5	under subsections (d) and (e) of this section would exceed
