- 12 **Section 1.** W.S. 27-14-206 by creating a new
- 13 subsection (g) is amended to read:

27-14-206. Public contract work; coverage procedure; 1 2 responsibility on private contracts; controlled insurance 3 plans. 4 5 (g) An owner or principal contractor of a construction project may apply to the division for approval 6 7 of a controlled insurance plan under which the owner or principal contractor shall be responsible to submit payroll 8 9 reports and to pay premium for all employees on the 10 project, subject to the following: 11 12 (i) The construction project is located entirely 13 within the state; 14 15 (ii) The aggregate construction value of the 16 project is at least two hundred million dollars 17 (\$200,000,000.00). For purposes of this paragraph, "aggregate construction value" means the cost of the 18 19 project's design, required permits, utilities installation, 20 site excavation, building construction, equipment and 21 furnishings, but does not include financing costs; 22 23 (iii) Any party proposing a controlled insurance plan pursuant to this section shall submit an application 24

1	for approval to the director on a form prescribed by the
2	division not less than forty-five (45) days prior to the
3	commencement of bidding procedures for the primary
4	contractor;

6	(iv) The application for approval of a
7	controlled insurance plan shall include:

9	(A) The name, including the type of
10	business entity, of the owner or principal contractor who
11	will operate the controlled insurance plan;

13	(B) A detailed description of the project,
14	including a list of the subcontractor categories to be used
15	on the project;

17	(C) An estimate of the number of persons
18	employed in each category of subcontractor;

20	(D) A financial statement demonstrating the
21	aggregate construction cost of the project; and

23	(E) Other information as prescribed by rule
24	and regulation of the division.

A 5 determination approving a controlled insurance plan shall include a determination of the premium rate or rates to be 6 7 paid on wages reported under the controlled insurance plan; 8 9 (vi) Nothing in this section shall modify the rights and remedies between an employer and its employees 10 11 as provided in W.S. 27-14-104; 12 13 (vii) The costs of claims for an injury to an employee covered by a controlled insurance plan shall be 14 assigned to the claims experience of the injured employee's 15 16 employer without regard to the operator of the controlled 17 insurance plan. 18 19 Section 2.
