Driver services fees.

Sponsored by: Joint Transportation, Highways and Military  
Affairs Interim Committee

A BILL

for

1 AN ACT relating to driver services; increasing driver's  
2 licenses fees and other driver services fees as specified;  
3 and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 31-7-105(d)(ii) and (iii),  
8 31-7-113(a)(i) through (ix), (d) and (e) and 31-8-104 are  
9 amended to read:

11 **31-7-105. Administrative hearings.**

12

13 (d) Before suspending, revoking, canceling or denying  
14 the license or driving privilege of any person under this  
15 act or disqualifying a person from driving a commercial  
16 motor vehicle pursuant to W.S. 31-7-305 and 31-7-307, the

1 department shall immediately advise the licensee in  
2 writing:

3

4 (ii) If the request for hearing is only to  
5 receive limited driving privileges, that the request shall  
6 be for a record review conducted by the department. The  
7 request for a record review under this paragraph shall be  
8 accompanied by a fee of ~~fifteen dollars (\$15.00)~~ thirty  
9 dollars (\$30.00);

10

11 (iii) If the request for hearing is for any  
12 purpose other than specified under paragraph (d)(ii) of  
13 this section, that the request shall be for a hearing  
14 before a hearing examiner within the office of  
15 administrative hearings. The request for a hearing before  
16 the office of administrative hearings under this paragraph  
17 shall be accompanied by a fee of ~~twenty five dollars~~  
18 ~~(\$25.00)~~ forty-five dollars (\$45.00).

(iv) Duplicate or renewal.....~~\$15.00~~ \$30.00

(v) Extension or renewal.....~~\$15.00~~ \$30.00

(vi) Commercial driver's license....~~\$25.00~~ \$45.00

(vii) Commercial driver instruction permit  
.....~~\$20.00~~ \$45.00

(viii) Commercial license renewal or duplicate  
.....~~\$20.00~~ \$40.00

(ix) Commercial driver's license skills test  
conducted by the department.....~~\$40.00~~ \$75.00

(d) If a driver's license with limited driving  
privileges is granted pursuant to W.S. 31-7-105(f), the fee

1 shall be ~~twenty five dollars (\$25.00)~~ forty-five dollars  
2 (\$45.00).

4 (e) Notwithstanding W.S. 31-7-131(c), if a driver's  
5 license is reinstated after a period of suspension or  
6 revocation, the fee for the reinstatement shall be ~~fifty~~  
7 ~~dollars (\$50.00)~~ ninety dollars (\$90.00) unless the final  
8 decision by the hearing examiner, or a court reverses the  
9 action taken by the department. If a driver's license is  
10 reinstated after suspension for nonpayment of child support  
11 pursuant to W.S. 20-6-111 or 20-6-112, the fee for  
12 reinstatement shall be not more than five dollars (\$5.00).

14 **31-8-104. Fees.**

15

16 Every applicant for an identification card shall pay ~~ten~~  
17 ~~dollars (\$10.00)~~ twenty dollars (\$20.00) to the department.

18 The state treasurer shall credit identification card fees  
19 to the highway fund.

20

21 **Section 2.** This act is effective July 1, 2008.
