7 **Section 1.** W.S. 27-4-202 is amended to read:

- 11 (a) Every employer shall pay to each of his or her
- 12 employees wages at a rate of not less than five dollars and
- 13 <u>fifteen cents (\$5.15)</u> seven dollars and twenty-five cents
- 14 (\$7.25) per hour.

1 Effective April 1, 2001 July 1, 2010 thereafter, all employers who employ tipped employees shall 2 not pay less than two dollars and thirteen cents (\$2.13) 3 five dollars (\$5.00) per hour to his tipped employees. 4 5 Provided further, if the wage paid by the employer combined with the tips received by the employee during a given pay 6 period does not equal at least the applicable minimum wage 7 as prescribed in subsection (a) of this section, the 8 9 employer shall pay the difference to the tipped employee. 10 For the purposes of this act, all "tip" employees shall 11 furnish monthly to their respective employers the daily record of tips required to be kept by "tip" employees under 12 13 the laws of the United States and upon the forms prescribed by the internal revenue service of the United States 14 The daily record of tips shall 15 treasury department. constitute prima facie proof of the amount of tips received 16 17 by the employee. Proof of a customary tipping percentage of sales or service shall also be an admissible form of proof 18 of the amount of tips. A "tip" employee is one who 19 customarily and regularly receives more than thirty dollars 20 21 (\$30.00) a month in tips.

23 (c) In lieu of the rate prescribed in subsection (a) 24 of this section, any employer may pay any employee who has

not attained the age of twenty (20) years a wage which is 1 2 not less than four dollars and twenty five cents (\$4.25) 3 six dollars and fifteen cents (\$6.15) per hour during the 4 first ninety (90) consecutive days after the employee is 5 initially employed by the employer. No employer may take any action to displace employees, including partial 6 displacements such as reduction in hours, wages or 7 employment benefits for purposes of hiring individuals at 8 9 the wage authorized in this subsection. 10 Section 2. This act is effective July 1, 2010. 11
