for

- 1 AN ACT relating to the Wyoming cultural trust fund board;
- 2 expanding membership on the board; providing for ex officio
- 3 membership on the board; providing for terms; providing an
- 4 appropriation; and providing for an effective date.

6 Be It Enacted by the Legislature of the State of Wyoming:

- 8 **Section 1.** W.S. 9-2-2305(a) (intro), (i), (ii) (intro)
- 9 and (b) is amended to read:

- 11 9-2-2305. Wyoming cultural trust fund board;
- 12 creation; members.

- 14 (a) There is created the Wyoming cultural trust fund
- 15 board. The board shall consist of five (5) eight (8)
- 16 members, as follows:

2	(i) The administrator of the division of
3	cultural resources or his designee who shall serve as an ex
4	officio member of the board, without a vote; and

6	(ii) Four (4) Seven (7) persons appointed by the
7	governor and confirmed by the senate from the following
8	nominees: who are residents of Wyoming. Board membership
9	shall reflect a broad spectrum of experiences, including,
LO	but not limited to, the arts, history, archaeology,
L1	humanities and cultural and heritage tourism.

L3	(b) Except for the <u>initial board</u> <u>board</u> members
L4	initially appointed on March 1, 2013, each appointed member
L5	of the board shall serve for a term of three (3) years. Of
L6	the initial appointees, one (1) member shall be appointed
L7	for one (1) year, two (2) members shall be appointed for
L8	two (2) years and two (2) members three (3) appointees
L9	initially appointed on March 1, 2013, one (1) member shall
20	be appointed for one (1) year, one (1) member shall be
21	appointed for two (2) years and one (1) member shall be
22	appointed for three (3) years. <u>Thereafter each board</u>
23	member shall serve for a term of three (3) years. The
24	governor may remove any member as provided in W S 9-1-202

2 HB0019 1 A vacancy on the board shall be filled for the balance of

2 the unexpired term. The board shall select one (1) of its

3 members to serve as chairman.

5 **Section 2.** W.S. 9-2-2305(a)(ii)(A) and (B) is

6 repealed.

7

8 **Section 3.** There is appropriated twelve thousand

9 dollars (\$12,000.00) from the general fund to the Wyoming

10 cultural trust fund board. This appropriation shall be for

11 the period beginning with the effective date of this act

12 and ending June 30, 2014. This appropriation shall only be

13 expended for the purpose of staffing the cultural trust

14 fund board. Notwithstanding any other provision of law,

15 this appropriation shall not be transferred or expended for

16 any other purpose and any unexpended, unobligated funds

17 remaining from this appropriation shall revert as provided

18 by law on June 30, 2014.

Section 4. This act is effective March 1, 2013.
