1 A JOINT RESOLUTION requesting Congress to issue a

2 moratorium on the closing of United States Postal Service

3 offices in Wyoming.

5 WHEREAS, in its most recent fiscal year, the United States

6 Postal Service sustained the largest net operating loss in

7 its history, and in response has begun the process of

8 closing more than three thousand (3,000) local post offices

9 nationwide; and

11 WHEREAS, in Wyoming, up to forty-three (43) post offices

12 are in the process or under the threat of closing; and

14 WHEREAS, the closing of post offices will have a

15 devastating impact on the communities which they serve; and

- 1 WHEREAS, the physical distances between rural post offices
- 2 in Wyoming will necessitate great hardship on Wyoming
- 3 citizens if closures of rural post offices occur, requiring
- 4 residents to travel great distances for the privilege of
- 5 obtaining their mail; and

- 7 WHEREAS, there is significant question whether the cost of
- 8 providing service to rural Wyoming is a primary factor in
- 9 the operating loss; and

- 11 WHEREAS, rural communities bear an unequal burden from the
- 12 postal service's attempts to initiate cost cutting through
- 13 post office closures rather than consideration of systemic
- 14 cost containment measures; and

15

- 16 WHEREAS, before an office is closed it is essential to
- 17 determine not only the savings to the postal service, but
- 18 also the impact on the local community; and

19

- 20 WHEREAS, the loss of a post office not only hinders the
- 21 economic development of a community, but also threatens the
- 22 health, safety and welfare of its residents by causing
- 23 additional delays in the delivery of vital medications and
- 24 correspondence.

2 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE

3 LEGISLATURE OF THE STATE OF WYOMING:

5 Section 1. That the Legislature of the State of Wyoming respectfully requests that the United 6 States Congress place a moratorium on the closing of post office 7 locations in Wyoming and requests that Congress establish a 8 9 blue ribbon panel to investigate the causes of the postal service operating losses, other systemic cost cutting 10 approaches, the actual cost to the postal service in 11 maintaining the rural offices and the impact on 12

15 Section 2. That the Secretary of State of Wyoming transmit copies of this resolution to the President of the 16 United States, to the President of the Senate and the 17 Speaker of the House of Representatives of the United 18 the Wyoming Congressional 19 States Congress and to 20 Delegation.
