A BILL

for

1 AN ACT relating to alcoholic beverages; increasing the
2 limitation on shipment of wine to households; and providing
3 for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

6

7 **Section 1.** W.S. 12-2-204(a), (b) and (d)(i) and
8 12-4-412(h)(i) are amended to read:

9

10 **12-2-204. Out-of-state shipment of manufactured wine;**
11 **license; fees; restrictions; conditions.**

13 (a) Notwithstanding any law, rule or regulation to
14 the contrary, any person currently licensed in its state of
15 domicile as an alcoholic liquor or malt beverage

1 manufacturer, importer, wholesaler or retailer who obtains
2 an out-of-state shipper's license, as provided in this
3 section, may ship no more than a total of ~~eighteen (18)~~
4 thirty-six (36) liters of manufactured wine directly to any
5 one (1) household in this state in any twelve (12) month
6 period.

7
8 (b) Notwithstanding any law, rule or regulation to
9 the contrary, any person currently licensed in its state of
10 domicile as an alcoholic liquor or malt beverage
11 manufacturer, importer, wholesaler or retailer who obtains
12 an out-of-state shipper's license, as provided in this
13 section, may ship to any Wyoming retail establishment which
14 holds a liquor license in this state or any household in
15 this state any manufactured wine which is not listed with
16 the liquor division as part of its inventory and
17 distribution operation.

19 (d) Any out-of-state shippers licensed pursuant to
20 this section shall:

21
22 (i) Not ship more than a total of ~~eighteen (18)~~
23 thirty-six (36) liters of manufactured wine to any one (1)

1 household in this state during any twelve (12) month
2 period. In the event any out-of-state shipper ships more
3 than ninety (90) liters of any particular manufactured wine
4 to any combination of households or licensed retailers in
5 this state, the out-of-state shipper shall offer to sell
6 the manufactured wine to the liquor division at wholesale
7 prices;

9 **12-4-412. Microbrewery and winery permits;**
10 **authorized; conditions; dual permits and licenses;**
11 **satellite winery permits; direct shipment of wine; fees.**

12

13 (h) Any licensed winery holding a winery permit
14 pursuant to this section shall:

15

16 (i) Not ship more than a total of ~~eighteen (18)~~
17 thirty-six (36) liters of its manufactured wine to any one
18 (1) household in this state during any twelve (12) month
19 period;

21 **Section 2.** This act is effective July 1, 2015.
