A BILL

for

AN ACT relating to supplemental appropriations for the 1 operation of state government; increasing or decreasing 2 certain amounts; adjusting the number of authorized positions; 3 modifying prior appropriations; making additional 4 appropriations; making certain appropriations subject to the 5 terms and conditions specified; providing transfers of certain 6 funds as specified; and providing for an effective date. 7



Of this general fund appropriation, up to two hundred fifty thousand 7 dollars (\$250,000.00) shall only be expended for statewide data collection 8 and research on the impact of wild or feral horses under federal jurisdiction in Wyoming including assessment of baseline range conditions; 9 dietary overlap between horses and wildlife; developing independent, 10 11 scientific bases to count and model wild or feral horse populations; and to gather other information that could be used to protect state and 12 13 private lands to control the number of wild or feral horse populations 14 within the state of Wyoming. The department shall report on the expenditure of the funds and its findings to the joint appropriations 15 16 interim committee and the joint agriculture, state and public lands and 17 water resources interim committee not later than October 31, 2014 and not 18 later than October 31, 2015. 


