A BILL

for

1 AN ACT relating to motor vehicle registration; requiring
2 county treasurers to issue farm registration stickers as
3 specified; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 31-2-204(b) is amended to read:

9 **31-2-204. Issuance of certificates of registration**
10 **and license plates by county; form.**

12 (b) Except as otherwise provided, license plates
13 shall be of metal not less than twelve (12) inches long in
14 the left-hand end of which shall be arabic numerals for the
15 county in which issued, followed by the bucking horse and

1 rider emblem and a distinctive number assigned to the
2 vehicle, set forth in numerals and letters as determined by
3 the department and above or underneath such numerals shall
4 be the word "Wyoming" and arabic numerals for the year of
5 issue or validation. License plates issued to dealers and
6 for state or federal official forestry vehicles,
7 motorcycles, multipurpose vehicles and trailers shall
8 contain appropriate identification which may be in lieu of
9 the bucking horse and rider emblem. After the county number
10 on the left-hand end, the license plate may also contain a
11 distinctive symbol or letters, as determined by the
12 department, indicating vehicle type. License plates shall
13 be changed or validated annually. There shall be a marked
14 contrast between the color of the plate and that of the
15 numerals and letters and the background of all plates shall
16 be fully reflectorized. Plates for light utility trailers
17 under one thousand (1,000) pounds, motorcycles and
18 multipurpose vehicles shall not be less than three (3)
19 inches wide and six (6) inches long. Antique license plates
20 shall bear no date and shall bear the inscription "Pioneer
21 Wyo". Distinctive license farm stickers shall be issued by
22 the county treasurer upon request for trucks and trailers
23 used by any farmer or rancher for the transportation of

1 livestock, feed or unprocessed agricultural products owned
2 and produced by the farmer or rancher from the place of
3 production to market and of ranch supplies intended solely
4 for the use of the farmer or rancher, and not for sale, on
5 the return trip, and not for the transportation of goods
6 and persons for hire. Farm stickers shall bear the
7 inscription "Farm". Upon application to the department and
8 payment of a fee as provided by W.S. 31-3-102(a)(xix),
9 veteran license stickers bearing the inscription "Veteran"
10 and designating the conflict service of the veteran may be
11 issued to the veterans' commission in a format approved by
12 the department. The veterans' commission may sell the
13 veteran license sticker to qualified veterans at a fee not
14 to exceed cost, plus ten dollars (\$10.00) per vehicle. Any
15 fees collected by the veterans' commission under this
16 subsection shall be deposited in the veterans' commission
17 expendable trust fund. The veterans' commission shall
18 establish eligibility criteria for veterans applying for a
19 veteran license sticker. A qualified veteran purchasing a
20 veteran license sticker manufactured by the department and
21 sold by the veterans' commission may display the sticker on
22 the license plate issued by the county treasurer. The
23 provisions of W.S. 31-2-205(a)(iv) shall not apply to any

1 veteran license sticker manufactured by the department and
2 displayed as provided in this section.

4 **Section 2.** This act is effective July 1, 2015.
