A BILL

for

1 AN ACT relating to administration of government; requiring
2 public reports on the use of the governor's exercise of
3 specified budget powers, on state agency contracts for
4 services and supplies and on revenues received by state
5 agencies as specified; and providing for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

8

9 **Section 1.** W.S. 9-2-1005 by creating a new subsection
10 (p), 9-2-1016(b) by creating a new paragraph (xxiv) and
11 9-2-1036(c) by creating a new paragraph (iv),
12 (d)(ii)(intro) and by creating a new subsection (h) are
13 amended to read:

14

1 **9-2-1005. Payment of warrants; budget powers of**
2 **governor; agency budgets; federal funds; new employees.**

3
4 (p) The governor shall make available monthly for
5 public inspection information on the exercise of his
6 authority under paragraph (b)(ii) and subsection (g) of
7 this section for the immediately preceding month. The
8 information shall be made available on the Wyoming public
9 finance and expenditure of funds website created by W.S.
10 9-2-1036(a).

11
12 **9-2-1016. General services division.**

13
14 (b) For the purpose of this subsection the term
15 "agencies" does not include the University of Wyoming,
16 community college districts, or school districts. It does
17 not include the department of transportation except as to
18 paragraphs (xi), (xii) and (xiii) of this subsection. The
19 department through the general services division shall:

20
21 (xxiv) Make available for public inspection on
22 the Wyoming public finance and expenditure of funds website
23 created by W.S. 9-2-1036(a) a copy of any contract or other

1 agreement entered into by an agency for supplies or
2 services subject to this section.

4 **9-2-1036. Wyoming public finance and expenditure of**
5 **funds website.**

7 (c) The department shall:

8

9 (iv) Post or provide a link on the website to
10 any public financial information specifically required by
11 law to be made available for inclusion on the website.

12

13 (d) The department may:

14

15 (ii) Subject to subsection (h) of this section,
16 determine what public financial information shall be
17 provided by participating state entities, provided that the
18 public financial information:

19

20 (h) A participating state entity shall provide to the
21 department for inclusion on the Wyoming public finance
22 website quarterly reports accounting for all revenues

1 received by that participating state entity that qualify as
2 public financial information, regardless of source.

3

4 **Section 2.** This act is effective July 1, 2016.
