 (a) As used in this act:
 (xi) "Physical therapy diagnosis" means a systematic examination process, excluding electrodiagnostic tests, that culminates in assigning a diagnostic label identifying the primary dysfunction towards which physical therapy treatment will be directed, but shall not include a medical diagnosis or a diagnosis of disease;".
