AN ACT relating to business entities; specifying that a series limited liability company may be named or designated in any manner; requiring registered agents to maintain series naming or designation information; prohibiting the adoption of rules relating to series naming or designation requirements and filing requirements; imposing a fee for series limited liability companies as specified; requiring the repeal of specified rules; providing an appropriation; and providing for an effective date.
