The secretary of state shall consult with the department of enterprise technology services and the blockchain task force regarding the scope of the study. The results of the study shall be reported to the blockchain task force during the 2019 legislative interim. Notwithstanding any other provision of law, this appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2020.".
