Any rules adopted by the department of revenue in accordance with this section shall take effect on July 1, 2019. Any rules adopted by the department of health in accordance with W.S. 39-11-109(c)(vi) shall continue in effect through June 30, 2019.

Section 4.

(a) Except as provided in subsection (b) of this section, this act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.

(b) Sections 1 and 2 of this act are effective July 1, 2019." HALLINAN
