However, Nothing in W.S. 18-5-201 through 18-5-208 shall be construed to contravene any zoning authority of any incorporated city or town.

(b) No zoning resolution or plan shall prevent any use or occupancy reasonably necessary to the extraction or production of the mineral resources in or under any lands subject thereto.

(c) No zoning resolution or plan shall regulate or restrict, in any manner different from that applicable to a public school, the location or use of buildings or structures of a private school or the use, condition of use or occupancy of lands for a private school, provided that the private school meets all of the following requirements:

(i) Is certified by the professional engineer or architect of record for the private school as being substantially similar to school facility

commission guidelines for education buildings and siting and is designed to be constructed with appropriate materials, means and methods;

(ii) Has capacity for fifty (50) students or more;

(iii) Is owned and operated by a not for profit Wyoming corporation.

(d) When a property that once contained a private school no longer contains a private school that meets the requirements of subsection (c) of the section, subsection (c) shall not apply to the county commissioners' governance of that property. The county commissioners may regulate and restrict the location and use of buildings and structures and the use, condition of use or occupancy of lands for residence, recreation, agriculture, industry, commerce, public use and other purposes on the property as it may for any other property in the unincorporated area of the county.
