- (e) No positions authorized in this section and no funding provided in this section shall be included in the supreme court's standard 2021-2022 biennial budget. The supreme court may include in an exception budget request for the 2021-2022 biennium such funds and positions as it determines necessary to support the chancery court provided by this act.".
