10 (a) Every corporation organized under the laws of this state and every foreign corporation which obtains the right 11 12 to transact and carry on business within this state (except 13 banks, insurance companies and savings and loan associations) 14 shall file with the secretary of state on or before the first registration of every year 15 day of the month of 16 certification, under the penalty of perjury, by its treasurer 17 or other fiscal agent setting forth its capital, property and 18 assets located and employed in the state of Wyoming. The 19 statement shall give the names and addresses of its officers 20 and directors and the address of its principal office. On or 21 before the first day of the month of registration of every 22 year the corporation shall pay to the secretary of state in 23 addition to all other statutory taxes and fees a license tax

4 (a) Every limited liability company organized under the 5 laws of this state and every foreign limited liability company which obtains a certificate of authority to transact and carry 6 on business within this state shall file with the secretary 7 of state on or before the first day of the month of 8 9 organization of every year a certification, under the penalty 10 of perjury, by its treasurer or other fiscal agent setting forth its capital, property and assets located and employed 11 12 in the state of Wyoming. The statement shall give the address 13 of its principal office. On or before the first day of the month of organization of every year the limited liability 14 15 company or foreign limited liability company shall pay to the 16 secretary of state in addition to all other statutory taxes 17 and fees a license fee based upon the sum of its capital, property and assets reported, of fifty dollars (\$50.00) one 18 19 hundred dollars (\$100.00) or two-tenths of one mill on the 20 dollar (\$.0002), whichever is greater.
